Partnership Plan for Children in Out-of-Home Care

We Believe: We are all responsible for the well-being of children in foster care. Children need normalcy in their lives regardless of where they live. They need loving and skillful parenting which honors their loyalty to their biological family. Biological parents, care providers, and agency staff understand that neither of us can succeed by ourselves.

We Share: All members of this partnership will behave professionally while understanding that human emotions are acceptable and expected. We will share all relevant information promptly, while respecting the confidentiality of the child and family. The family, care providers, and agency staff will work together as a team in developing any and all plans that involve them. This includes, without limitation, court hearings, school meetings, visitation, and treatment planning. Agency staff will support and facilitate care provider and birth family participation through timely notification.

We Commit: The best interest of children will always be at the forefront of everything we do. Children will be afforded normalcy based on individual needs and we will work to remove any barriers that prevent this. ALL children deserve excellent parenting which requires love, commitment, appropriate supervision, positive methods of discipline, encouragement, respect and acceptance of their individuality, opportunities to develop interests and skills, equal participation in family life, and awareness of how their trauma impacts all facets of their lives. Care providers and agency staff must be respectful and learn about the child's religion, culture and ethnicity, and any special circumstances affecting the child's care.

Children deserve a family and to have stability in their lives. They will only move from a home when it is in their best interest to do so. All children deserve thoughtful and careful transitions that are respectful of his/her developmental stage, psychological needs, and that are emotionally considerate. Transitions will always be mindful of the child's belongings, allowing for gradual moves, and if possible, allowing of continued contact with the care provider after the child leaves. Care providers and agency staff will respect the child's ties to his/her biological family/kin and will assist in ensuring that visitation is encouraged, never held from a child or parent due to case status, behaviors, or participation in their case plan.

As long as the permanency plan is reunification of the child with his/her family, agency staff and care providers will work together to assist the biological parents in improving their ability to care for, and protect their children, along with being provided thoughtful, encouraging, and engaging visitation.
